**ORDER**

In supersession of earlier order No. DC/Scrapping Cell/2023/075645633 /30937 dated 29.03.2023, following registered RVSFs are voluntarily associated with Enforcement Team in the different MCD Zones of Delhi for scrapping of end of life vehicles (ELVs) found plying/deemed plying (parked at public place) on the roads of Delhi as per RVSF rules, 2021 notified by Ministry of Road Transport and Highways vide notifications no. GSR. 653 (E) dated 23.09.2021 & GSR. 695 (E) dated 13.09.2022.

2.RVSFs need to deploy their cranes and other necessary infrastructure for aforementioned purpose. MCD zonewise allocation of the RVSF for the purpose of impounding/scrapping of ELVS is as below:

3. RVSF have to submit Certificate of Deposit (COD), certificate of vehicle scrapping and proof of payment to vehicle owners for the vehicle handed over to them.

4. In case, a vehicle owner does not report to RVSF with 03 months for payment, then scrap value has to be deposited in Government Treasury of Transport Department.

5. The Value of scrap has to be decided as per the formulae of reserve price set up by Ministry of Steel OM. F.No. S-31037/1/2022-MFM dated 23.01.2023.

6.The Zone of action will be in round-robin manner as per the serial number in the Order.

7. EO(HQ), will maintain a register of inventory of all vehicle seized by enforcement team and handed over to scrappers with details of team In-charge who seized, RVSF to whom it has been handed over, Submission of COD, Payment and Certificate of Vehicle Scrapping.
